I. CALL MEETING TO ORDER

II. APPROVE AGENDA

V. INFORMATION ITEMS

- a. Financial Review Our Bookkeeper, Sonya Yonts, reviewed the financials and answered question for the committee.
- b. Review College Visits A committee member learned that our College Visit Policy only allows two College Visit days for Seniors. It does not allow College Visit days for Juniors. The committee would like to add one College Visit day for Juniors. We will revise this policy and vote to approve the updated policy at next month's meeting.
- c. Loss of Privileges A committee member created a Loss of Privileges Chart for our students. We will revise and add some new items to the chart and also a path to regain privileges. We will revise this document and vote to approve the updated policy at next month's meeting.

VI. ACTION ITEMS

- a. 504 Waiver Currently, our 504 Plans are reviewed annually. It is proposed that we move to reviewing the plans every three years. The committee would like to be sure that the wording for this policy clearly states that the plans are still able to be reviewed annually, or more frequently, upon request from the 504 Coordinator, a parent or a teacher but would now also have the availability to be reviewed every three years. We will update the wording on this waiver and vote to approve this change at next month's meeting.
- b. Professional Development Plan Dr Brown would like to take a group of LEAD teachers to a Solution Tree Conference in Fort Worth, TX in June for "Professional Learning Communities at Work" Institute. The committee thought this was a great resource for our school. Coy Zerhusen motioned to approve the Fort Worth PD Institute, seconded by Marcia Elder. The PD Institute was approved 5-0.
